1. Council approved Minutes from January 12, 2015 Work Session.
2. Council approved Minutes from January 12, 2015 Regular Council Meeting.
3. Council voted to approve the request of Chris King to rezone from an R-1 to a RTZ zero lot line on the property located at Tax Map R10, Parcel 44.
4. Council voted to rescind the motion for the digital sign from the January 12, 2015 council meeting.
5. Council voted that we form a committee that is balanced with opponents for and against moving the digital sign. The committee will work on whether to keep, move or reface the digital sign.
6. Council approved the Post-Development Stormwater Management for New Development and Redevelopment.
7. Council voted to approve the low bid from Construction 57, Inc. in the amount of \$308,925.00 for the 2014 Sidewalk Improvements.
8. Council approved the 2015 Georgia Classic Main Streets Memorandum of Understanding for the 2015 Program Year.
9. Council voted to approve the City Manager contacting owners of property at Chapman Road and Hwy 41 to obtain easements in order to clean the channel from the 4 tiles behind Grease Lightning down to Chapman Road.
10. Council approved taking responsibility for Pole #1 located at the Remco Business Center and pay the monthly bill of \$20.24 per month.
11. Council voted to gather information regarding costs to implement video recording of council meetings and to add it to the next council meeting agenda dated February 9, 2015.
12. Council approved adding additional signage at South Depot and Nashville Street which would have a picture of a truck with the "ghost buster" symbol with a line through it and a sign at Cotter and South Depot to keep trucks from going down Cotter. There will also be a Shaw sign installed on Lafayette Street between Federal Bridge and Emberson Drive and another larger two sided sign at the intersection of Lafayette and Emberson. Shaw will pay for the Shaw signs and City Crews will install.

13. Council voted to approve the appointment of Kim Brown to fill the unexpired term of Scott Pennington and the reappointment of Randall Peters and Johnny Gass to the Downtown Development Authority Committee for another term.
14. Council approved contracting one truck from Logan at \$65.00 per hour to help haul off spoils and haul in rock for the Candy Lane Sewer Project. The truck would be on an as-needed basis.
15. Council voted to approve the List of Roads for the City of Ringgold raising the speed limit on Interstate 75 from south of State Route 151 to the northern Ringgold city limit from 65 to 70 MPH.
16. Council voted to go into Executive Session.
17. Council voted to return to open session.
18. Council voted to move forward with obtaining options on two potential groundwater sites.
19. Council voted to adjourn.
